Agents can also become Members of LPPC (The Lindo Parfumo Perfume Club) and introduce their clients to also join – this way offering their clients fantastic benefits and free perfume and still earn full commission on any purchases they make EXCEPT on free product we may send a client or on any of the Crazy Club Specials which is a limited offer and usually practically at cost. Agents who are also LPPC Club Members also get to purchase these Crazy Club low cost specials but there will be no limit to how much an agent can purchase.

WHOLESALE PURCHASER

This is someone who does not wish to sell Lindo Parfumo products but on occasion may wish to purchase in bulk. Lindo Parfumo will negotiate pricing on any bulk direct order. An agent can also request further discounts on pricing if they have a bulk order . A bulk order is 100 +products at a time.

Agents may introduce others to Lindo Parfumo as provided for under the Opportunity Offerings, to participate in and receive benefits accordingly.

Margins / Profits: Lindo Parfumo makes no representation as to how much commission an Agent will earn. Commission earned will depend on the skills and efforts of an Agent.

Right of Agent to terminate activity with Lindo Parfumo: An Agent may terminate all activity with Lindo Parfumo at any time for any reason; all benefits also stop from this point.

Right of Lindo Parfumo to terminate Agent activity: The rights of an Agent may be terminated if the Agent: Fails to comply with any of the terms or conditions on this page, or any policies or procedures of Lindo Parfumo now in effect or as they may be amended, (AND/OR) Makes any misrepresentation, or engages in any unethical practice as an Agent, as determined by Lindo Parfumo in its sole discretion

Effect of Agent Termination: Upon termination for any reason, an Agent shall cease to be an Agent of Lindo Parfumo, and the Agent shall thereafter have no further rights to participate in or receive any benefits or commission under the Lindo Parfumo Commission Plan.

Relationship to Lindo Parfumo: The applicant is an Independent Agent. An Agent shall at no time adopt or use any word, logo, slogan or mark that is the same as or may be similar to or confusing with any trademark or service mark, logo or slogan owned or used by Lindo Parfumo. At no time during the term of this agreement or at any time thereafter shall an Agent or anyone acting on the Agent's behalf, attempt to apply for registration of any trade name or trademark owned or used by Lindo Parfumo.

Product Range: Lindo Parfumo reserves the right in its sole discretion to change its product line and prices at any time without notice and to amend the Terms and Conditions on this page, its Commission Plan and its Policies and Procedures upon giving the Representative at least 30 days written notice.
