We are required to obtain and share your information to provide you with our services in order to meet your needs and objectives. For these purposes, your information is collected and processed internally by our staff, representatives or sub-contractors. By signing the LPPC application form, you give us consent to obtain, process and share your information for these purposes only.

### LPPC Membership Rules

*Note that benefits are subject to change by Lindo Parfumo at its sole discretion when benefits, discounts and advantages change or are added to the offering. Liberty will notify all Members of such amendments by publishing them on the Lindo Parfumo website, Lindo Parfumo Facebook page and direct communication.*

*By becoming a member of LPPC and by paying the yearly membership fee, you confirm that:*

- you wish to become or to remain a member of the LPPC
- you agree to be bound by the rules
- we may use your nominated email address for all notifications required by the LPPC

Once you have become a member, Lindo Parfumo undertakes to provide you with the benefits that you choose to use and for which you qualify. A member shall have (60) sixty days (2 months) from the date on which the transaction was concluded to cancel his / her membership before renewal date for the following year.

*You agree that* by paying your membership fee to Lindo Parfumo you accept that these rules and any changes that we may make to the rules from time to time will apply to you.

***You agree that you have to purchase a minimum of 1 fragrance per month in order to maintain this membership. If you skip a purchase in any given month, you are well aware that you forfeit membership benefits for the rest of the year.***

Membership shall be restricted to:
